
Amendment


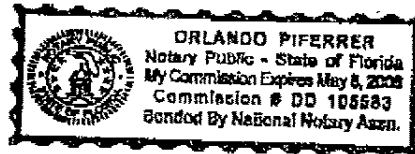
