

# ARTICLE I - NAME

The name of this componation is: SEXY DESIGN, CORP.

# ARTICLE II - DURATION

This componation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incomponation by the initial subscribers.

# ARTICLE III - PURPOSE
