## CERTIFICATE OF INCORPORATION OF SUE BARROSO ENTERPRISES, INC.

We, the undersigned, hereby associate ourselves for the purpose of becoming a close corporation for profit under Chapter 608, Part II Close Corporation, Florida Statutes.

## ARTICLE I NAME OF CORPORATION

The name of this corporation is SUE BARROSO ENTERPRISES, INC.

#### ARTICLE II GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is the following:

- a. To engage in the business of Marketing and Public Relations
- b. To engage in the business of the retail trade
- c. To engage in and carry on any other lawful business whatsoever reasonably allied with one or more of the foregoing purposes, or which is calculated, directly or indirectly, to promote the interests of the corporation or to enhance the value of its properties.

The maximum number of shares of stock with nominal or par value and the maximum number of shares without nominal or par value which the corporation is authorized to have outstanding at any time, the classes, with the distinguishing characteristics of each into which the same are divided, and the nominal or par


