## ARTICLES OF INCORPORATION

The undersigned HOLLY R. COLE, desires to become a body corporate and, as incorporator, does hereby make and file these Articles of Incorporation for a proposed corporation pursuant to the laws of Florida, and to that end hereby declares and affirms:

## ARTICLE I

The name of this corporation shall be:

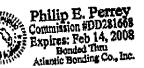
