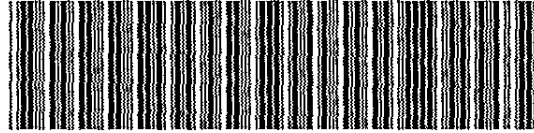

### FIFTH:


No debt of the corporation remains unpaid.
