

ARTICLES OF INCORPORATION OF INTERNATIONAL INVESTMENTS PROPERTIES INC.

ARTICLE I - NAME

The name of the Corporation is **INTERNATIONAL INVESTMENTS PROPERTIES INC.** (hereinafter called the "Corporation").
