The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## **ARTICLE I**

NAME-:

The name of this corporation is:

ARTICLE II-

# PRINCIPAL OFFICE AND MAILING ADDRESS:

## **ARTICLE III**

## **NATURE OF BUSINESS:**

(a) The general nature of business of the corporation to be conducted by the corporation shall be to engage in all facets of the marine industry.
