ARTICLES OF INCORPORATION OF ISLAND REPORTER, INC.

DIVISION OF STANDING

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME. The name of this Corporation is ISLAND REPORTER, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS. The principal place of business of this Corporation is 390 Pinellas Bayway, Suite D, Tierra Verde, Florida 33715.

ARTICLE III - DURATION. This Corporation shall have perpetual existence unless dissolved according to law.

ARTICLE IV - BUSINESS. The primary business of this Corporation is publishing a community newspaper and the sale of advertising, and any and all other lawful businesses for which corporations may be incorporated under the laws of the State of Florida, subject to the limitations by Chapter 621, Florida Statutes.
