ARTICLE I
NAME

The name of this corporation is **WHITE DRAGON CLEANING COMPANY, INC.** 16620 Brigadoon Drive, Tampa, FL 33618

ARTICLE II
DURATION

The corporation shall have a perpetual existence.

ARTICLE III
PURPOSE

This corporation is organized for the following purpose:

INITIAL BOARD OF DIRECTORS




