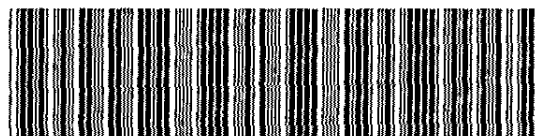

ARTICLES OF INCORPORATION  
OF

MADISON PIONEER TIMES, INC.  
(A Florida Corporation)

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE I. NAME

The name of this corporation is MADISON PIONEER TIMES, INC.

ARTICLE II. PURPOSE

The general purposes for which this corporation is organized are:

1. To engage in the business of News Paper for profit.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III. CORPORATE DURATION

The duration of this corporation is perpetual.

ARTICLE IV. CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class and shall be without par value.

ARTICLE V. ADDRESS

The initial post office address of the principal place of business of this corporation in the State of Florida is 1010 Shelby St., Madison, Florida 32340.

ARTICLE VI. DIRECTORS

This corporation shall consists of not more than 35 shareholders and NELSON A. PRYOR shall perform all the functions of the board of directors. This corporation shall have one director initially. The number of directors may be increased or decreased from time to time by-laws adopted by the membership of the corporation, but shall never be less than one.

ARTICLE VII. INITIAL DIRECTORS AND OFFICERS


ARTICLE X. AMENDMENT OF BYLAWS
