
ARTICLE THIRTEEN



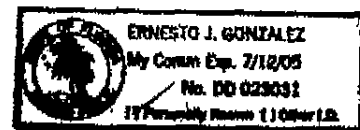
