The Articles of Incorporation of the undersigned corporation were originally filed on June 16, 2004 and assigned document number P04000092584. Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to Articles of Incorporation (these "Articles of Amendment"):

1. The name of the corporation is DTS Acquisitions, Inc.
2. "Article IV" of the Articles of Incorporation of the corporation is amended and restated in its entirety to read as follows:

"Article IV

The number of shares the corporation is authorized to issue is: 6,000"

3. These Articles of Amendment were duly approved and adopted by the Board of Directors of the corporation on July 20, 2004. The Board of Directors recommended approval of these Articles of Amendment to the Shareholders.
4. These Articles of Amendment were voted upon and duly approved, adopted, and ratified by all of the Shareholders of the corporation on July 20, 2004.

6. In all other respects, the Articles of Incorporation shall remain as they were prior to these Articles of Amendment being adopted.
