ARTICLES OF INCORPORATION**OF**STATE OF FLORIDA
JACKSONVILLE, FLORIDA**MARK I. BLOCK, M.D., P.A.**

The undersigned incorporator, for the purposes of forming a professional service corporation pursuant to the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is **MARK I. BLOCK, M.D., P.A.** (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is 201 South Biscayne Boulevard, Suite 3000, Miami, Florida 33131.
- THIRD:** The Corporation is authorized to issue 10,000 shares of common stock, \$1.00 par value per share.
