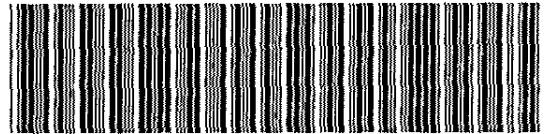

Jose Luis Hernandez - President.


ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.



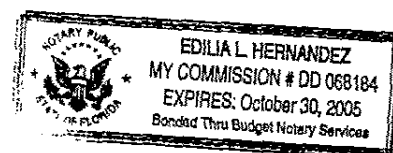


