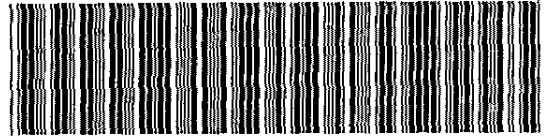

Bylaws

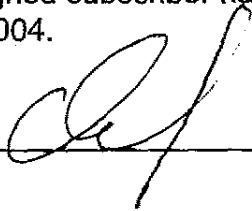

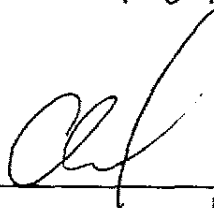
