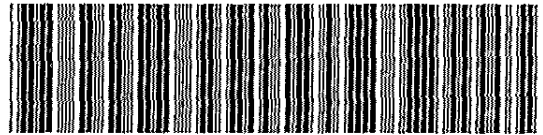

ARTICLE I - NAME


#### ARTICLE XI - INCORPORATOR


