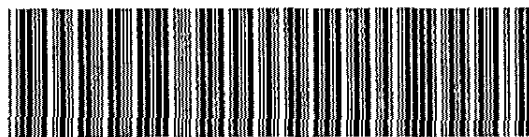

OF

ARTICLE I. NAME

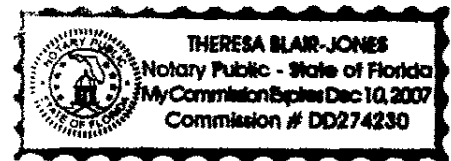
