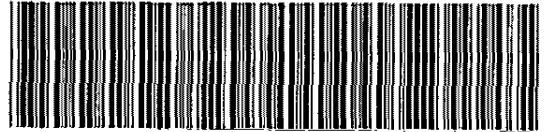

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation is:
