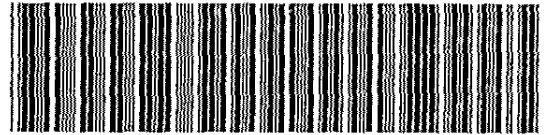

OF


ARTICLE VIII
