**ARTICLE I**                      **NAME**

The name of the corporation shall be GARY FAIR, INC.

**ARTICLE II**                      **DURATION**

The duration of said corporation is perpetual, beginning from the date that these Articles are filed with the Department of State.

**ARTICLE III**                      **PRINCIPAL OFFICE**

The principal place of business/mailling address is 6137 Meghan Avenue, Melbourne, Florida 32940.

**ARTICLE III**                      **PURPOSE**

The purpose for which the corporation is organized is to engage in construction and remodeling projects and any other lawful activity permitted under the laws of the United States and the state of Florida.

**ARTICLE IV**                      **SHARES**

The number of shares of stock is 100 shares of common stock having a par value of \$1.00 per share.

**ARTICLE VIII SPECIAL PROVISIONS**

The following additional provisions for the regulation of the business and for the conduct of the affairs of the Corporation and for creating, defining, limiting and regulating the powers of the Corporation, its shareholders and directors are hereby adopted as part of these Article of Incorporation.

1. No person shall be required to own, hold or control stock in the Corporation as a condition precedent to holding an office in this Corporation.
2. The Board of Directors may prescribe a method or methods for replacement of lost stock certificates, and prescribe reasonable conditions by way of security upon the issuance of new certificates therefore.
3. The Board of Directors, by affirmative vote of a majority of the directors then in office, and irrespective of any personal interest of any of its members, shall have the authority to establish reasonable compensation of all directors for services of the Corporation as directors, officers or otherwise.
