PREEMPTIVE RIGHTS



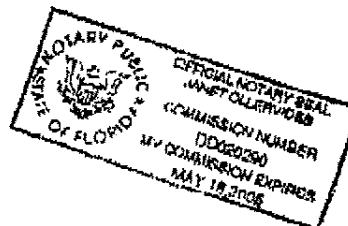
