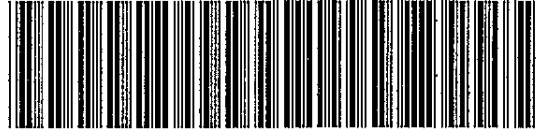



ARTICLE III-CAPITAL STOCK


This corporation is authorized to issue 100 (one-hundred) shares of no-par common stock.




