ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Doctors ER Services, Inc. and its address is c/o Spencer and Klein, P.A., Penthouse IIB, Two Alhambra Plaza, Coral Gables, Florida 33134.

ARTICLE II

DURATION

The duration of the corporation is perpetual.
