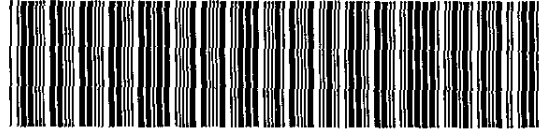



ARTICLE X AMENDMENT

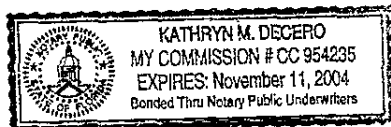




