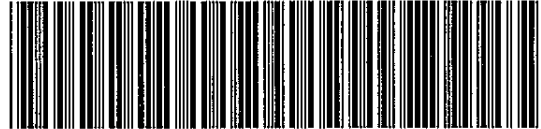

ARTICLE III: *PURPOSE AND POWERS*


