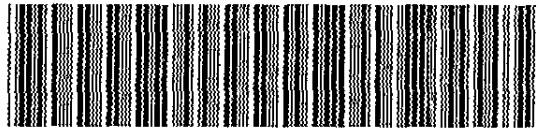

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is R.T. Bowers Electric, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office is 229 Raccoon Lane, Lorida, Florida 33857

**ARTICLE III: DURATION**

The duration of the corporation is perpetual.

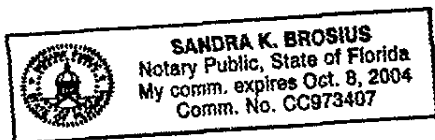

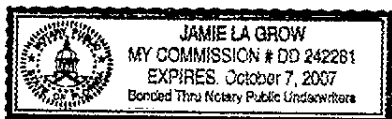
