**ARTICLE I. CORPORATE NAME AND INITIAL ADDRESS.**

The name of this corporation is: **Perez, Rodriguez & Associates, Inc.** Its initial address is 10331 SW 27<sup>th</sup> Street, Miami, Florida 33165. The Board of Directors from time to time may move this address to any other address in the State of Florida.

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida for a corporation.

**ARTICLE III. CAPITAL STOCK.**



ARTICLE IX. AMENDMENT.






