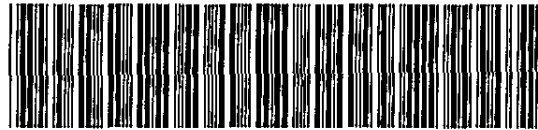

ARTICLES OF INCORPORATION

All-Access Enterprise INC.

ARTICLE I


