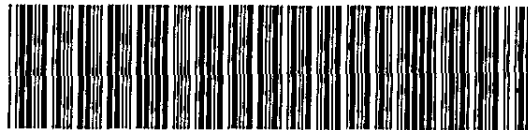

ARTICLES OF INCORPORATION
OF
EQUISCAN, INC.

ARTICLE I
NAME

The name of the corporation is: EQUISCAN, INC.

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSE




