
**AFFIDAVIT OF NON-REVOCATION**

BEFORE ME, the undersigned authority, personally appeared FRED JETT, who after being duly sworn, stated as follows:


1. He is over the age of eighteen years and makes this affidavit upon personal knowledge.

ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is CORNER CLUB, INC.

ARTICLE II

The existence of the Corporation shall begin on June 18, 2004.

ARTICLE III

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares. 
