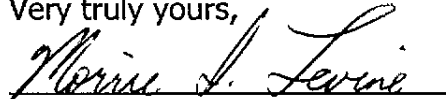

I, THE UNDERSIGNED, a natural person competent to contract, do hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I

The name of this corporation shall be:

PAUL BLAIR, P.A.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be to engage in every aspect of the practice of medicine. The professional services rendered by the corporation (as stated in Florida Statutes Chapter 621) may be rendered only through individuals duly licensed to render professional services as a medical professional under the laws of the State of Florida. The corporation shall not engage in any business other than the practice of medicine.

However, the corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own real and personal property necessary for the rendering of professional medical services.

The Common Stock of the corporation may not be issued to anyone other than an individual who is duly licensed to render professional medical services. No shareholder of the corporation shall enter into a voting trust agreement or other type of agreement vesting any other person with the authority to exercise the voting power of any or all of the shareholder's share of Common Stock of the corporation.

ARTICLE III

The maximum number of shares of capital stock that this corporation is authorized to have outstanding at any time is FIVE HUNDRED (500) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

The amount of capital with which this corporation will begin business shall be the sum of not less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE V

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE VI

The initial street address of the principal office of the corporation shall be:

ARTICLE XI

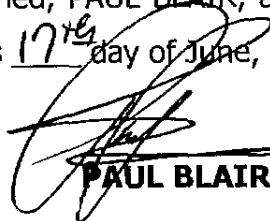

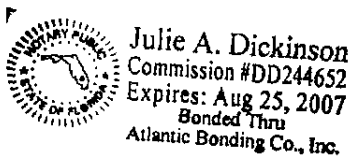

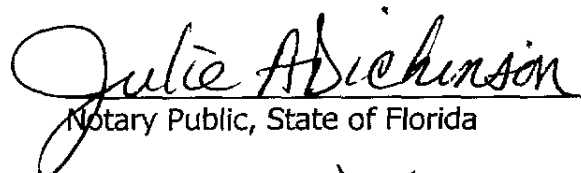
