NAME



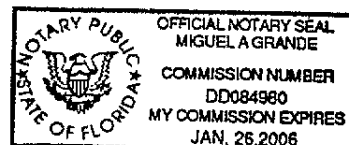


