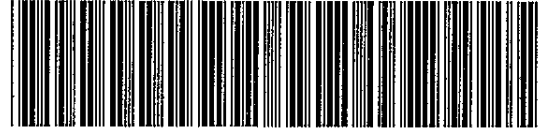



FIRST: The name of the corporation as currently filed with the Department of State is Amateur Extreme Martial Arts Association, Inc.


