ARTICLES OF INCORPORATION

OF

ALEXIS J. DeCAPRIO, P.A.

#### ARTICLE I. NAME

The name of this corporation is ALEXIS J. DeCAPRIO, P.A.

# ARTICLE II. DURATION

This corporation shall have perpetual existence.

# ARTICLE III. PURPOSE

The general nature and purposes of business to be transacted, promoted, and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of law and all its fields of specializations, as are engaged in by licensed attorneys.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
- c. To invest its funds in any type of investments permitted by law.
- d. To engage in no other business other than the rendition of professional services specified herein.

- c. Shares of the Corporation's stock and certificates shall be issued only to attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

### ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE X. INFORMATIONAL SHAREHOLDER ACTION

Any action of the Shareholders may be taken without a meeting or consent in writing setting forth the action so taken shall be signed by all the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the Corporation as part of the corporate records.

#### ARTICLE XI. INFORMAL DIRECTOR ACTION

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XII. SEVERANCE AND TERMINATION OF EMPLOYMENT

The Corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay the shareholder all amounts owing and lawfully due the shareholder by the corporation, except that such shares shall not be entitled to dividends.
