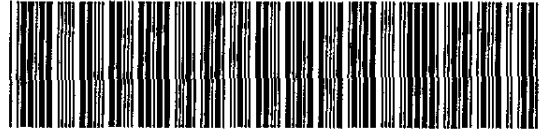




- ARTICLE I: The name of this corporation is Sun City Electronics, Inc.
- ARTICLE II: The existence of this corporation shall begin on June 21<sup>st</sup>, 2004.
- ARTICLE III: The principal place of business of the corporation shall be 99 SE Mizner Blvd., Apt 740, Boca Raton, Florida 33432.
- ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares. ARTICLE IX: The purpose of the corporation shall be to operate a business in the electronic industry.


