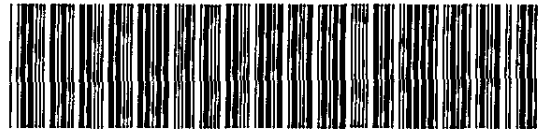

The undersigned, acting as Incorporator of a corporation under the Florida Statutes.

ARTICLE I - NAME

The name of the corporation is The Metropolitan Journal, Inc.

ARTICLE II - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III - DATE OF COMMENCEMENT

The date and time of the commencement of the corporation existence shall be the date of the filing of these Articles by the Department of State for the State of Florida.

ARTICLE IV - PURPOSE OF CORPORATION

The general purpose for which this Corporation is formed is to publish newspapers and magazines ; and all other business for which the corporation may be incorporated under the provisions of the Florida General Corporation Act of the state of Florida.


ARTICLE VIII - BYLAWS


