NAME, PRINCIPAL OFFICE, AND MAILING ADDRESS

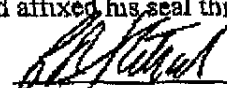

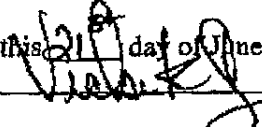

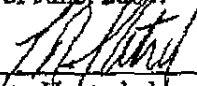
