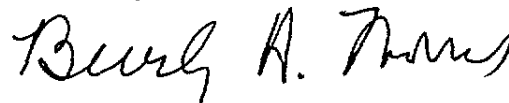

ARTICLES OF INCORPORATION

OF

The undersigned, desiring to form a corporation in accordance with Chapter 607 of the Florida Statutes, adopt the following Articles of Incorporation:

Article I - Name
