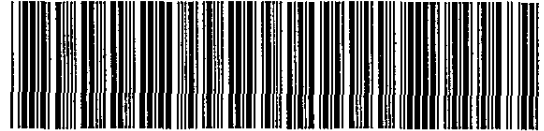

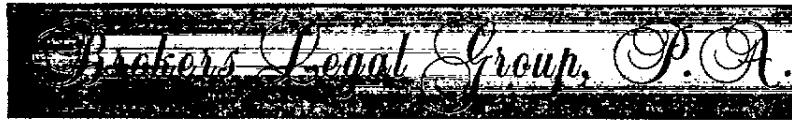

The purpose of the corporation is to engage in any lawful business permitted under law, and the term of the corporation is perpetual.

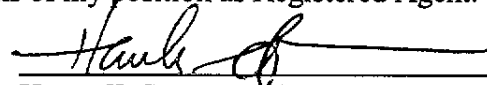
