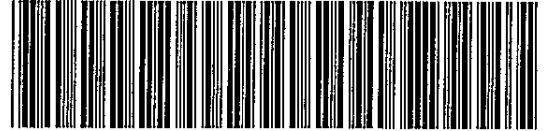
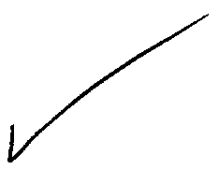

**ARTICLES OF INCORPORATION**

I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the provisions of the **General Business Corporation Act of the State of Florida**.

**ARTICLE I**



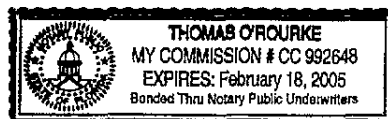


