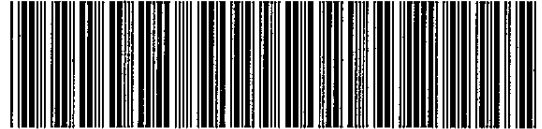

ARTICLE ONE (I) NAME

The name of this corporation shall be: **Faith & Hope Cleaning Services, Inc.**

ARTICLE TWO (II) PRINCIPAL OFFICE

The principal place for the transaction of business/ mailing address of this corporation is to be located in 520 Arnau Terrace, Jacksonville, Florida 32254.

ARTICLE THREE (III) PURPOSES

The general nature of the business or businesses to be transacted, conducted and carried on by this corporation shall be to engage in any activity or business permitted under the laws of the state of Florida.
