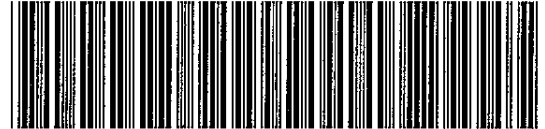



**ARTICLES OF INCORPORATION
OF
26-2 ASSOCIATES, INC.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE. 1 NAME

The name of the corporation shall be **26-2 ASSOCIATES, INC.**, and the address of the principal office of the corporation shall be 27 Pennock Lane #205, Jupiter, Florida 33458, and the mailing address shall be the same.
