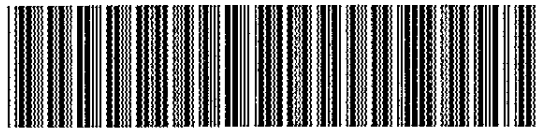



**ARTICLES OF INCORPORATION  
OF  
AIR'S A GAS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I


