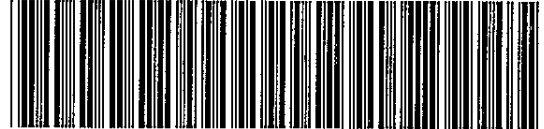

NAME

The name of this Corporation is Regal Home Health of Broward, Inc.

ARTICLE 2
