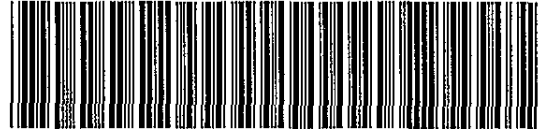

THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

FIRST: The name of the corporation is Metrosprings, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The date and time of the commencement of the corporate existence shall be the date of the filing of these Articles by the Department of State.

FOURTH: The purposes for which the corporation is organized are as follows:

- 1) To carry on the business of manufacture, export, import, repair, design, and sales in watches, clocks, and clockwork-operated devices;
- 2) To carry on the business of manufacture, export, import, repair, and sales in computers and related products;
- 3) To wholesale and deal farm, livestock and aquatic products;
- 4) To carry on the business of export, import and sales in jewelry, precious metals and accessories;
- 5) To sell real estate, and to act as a real estate agent and broker as well as real estate lessor and real estate manager;
- 6) To act as business consultant;
- 7) To act as travel agent;

- 8) To act as a health and car insurance agent and broker;
- 9) To carry on businesses of schools, language schools, educational institutions;
- 10) To manufacture, import and export underwear, shirts, nightwear, sportswear, women's and men's clothing, linen products, towels, bedspreads;
- 11) To carry on the business of publishers, booksellers, printers and book-binders; and
- 12) To engage in the transaction of any or all lawful purposes incident to the purposes set forth above under the provisions of the Florida Business Corporation Act.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1,000) SHARES of capital stock, \$.001 par value each.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is ONE (1) and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and qualified is:
