ARTICLES OF INCORPORATION OF

GREEN GORILLA, INC.

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I Name and Principal Office

The name of the Corporation shall be GREEN GORILLA, INC.. The address of the principal office of the corporation shall be Attn: Ned McLeod, 284 Park Avenue N., Winter Park, FL 32789.

ARTICLE II Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


