## ARTICLES OF INCORPORATION OF ERIC PARSONS CUSTOM FURNITURE DESIGN, INC.

The undersigned hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation in accordance with the laws of the State of Florida.

### ARTICLE I Name and Principal Office

The name of the corporation shall be Eric Parsons Custom Furniture Design, Inc. The principal office and mailing address of the corporation shall be located at 4706 Wandering Way, Tampa, Florida 33624.

#### ARTICLE II Term of Existence

The corporation shall have perpetual existence, commencing on June 23, 20@4.

### ARTICLE III Purpose

The general purpose of the corporation shall be to transact any and all lawful business for which corporations may be incorporated under Florida law.

### ARTICLE IV Powers

The corporation shall have all powers conferred by the laws of the State of Florida upon corporations.

### ARTICLE V Capital Stock

The corporation is authorized to issue ten thousand (10,000) shares of common voting stock having a par value of one cent (\$.01) per share.
