
ARTICLE IX - INDEMNIFICATION

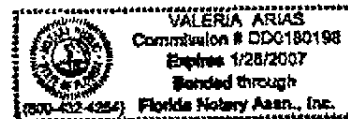
