## ARTICLES OF AMENDMENT

TO THE ARTICLES OF INCORPORATION OF ALL REAL ESTATE MANAGEMENT AND CONSULTING Pursuant to the provisions of Section 607.1003 and 607.1006 of the Florida Business

Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is All Real Estate Management and Consulting, Inc..
