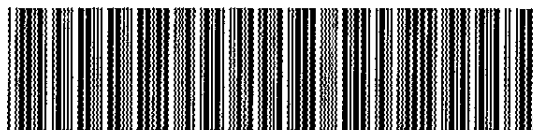

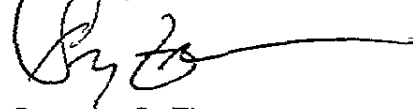

**ARTICLE I

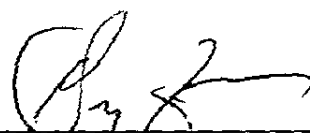

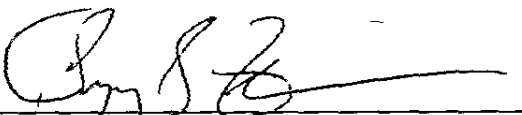
